QUESTION ONE (Compulsory)

- a) Using the natural law traditions in ethics:
 - Ending his life is a direct action against the value of life.
 - The accountant is not guilty of any action that would cause him to forfeit his own right to life, so the principle of forfeiture does not apply.
 - The use of that drug could be considered unavoidable.
 - Natural-law theorists would accept the use of the principle of proportionality in this case.
 - The good effect of relieving the pain cannot be achieved without death.
 - The accountant's death is the direct means of achieving the release from pain, so the accountant's death is intended.
 - No serious reason exists for administering the lethal drug, since relief from pain cannot justify directly killing an innocent person, an act that is actually murder.

Because the physician's action in administering a lethal drug to the accountant is a violation of a fundamental value and because the qualifying principles of forfeiture and double effect do not apply, the action is morally impermissible.

- b) By use of relevant examples, explain the following:
 - i. **The doctrine of double effect**: no matter what is reasonably done, one or more innocent human beings may be harmed or even die in the process of resolving the dilemma.
 - ii. **Virtue ethics**: should be based on a theory of the virtues rather than on a theory of what one ought to do
 - iii. Customary law: traditional tenents acceptable by members of a particular society
 - iv. **Business ethics**: examines the ethical and moral principles and problems that arise in a business environment
