a) '...A contract comes into existence when an offer by one party is unequivocally accepted by another and both parties have the requisite capacity. Some consideration must pass and the parties must have intended their dealings to give rise to a legally binding agreement. The purpose of the agreement must be legal and any necessary formalities must have been complied with...' – Anonymous.

Using relevant case laws and necessary illustrations, discuss the following elements of a contract:

- b) 'The High Court, Court of Appeal and all Subordinate Courts shall be guided by African Customary Law in civil cases in which one or more of the parties are subject to it or affected by it, so far as it is applicable and it is not repugnant to justice and morality or inconsistent with any written law, and shall decide all such cases according to substantial justice and without undue regard to technicalities of procedure and without undue delay' (*emphasis mine*) –*The Judicature Act, Section 3(2), Chapter 8 Laws of Kenya.* In light of the above statement, discuss the following issues:

The rest of the siblings are in support of that arrangement since it is allowed in their custom. Nevertheless, Ms. Jane Doe is opposed to that and she has come to you for advice. Briefly advise her the way forward.

QUESTION TWO

Nairobi Airlines Limited (NAL) ordered six Dreamliner aeroplanes in 2013 from Bolche Inc., with delivery to be at the Rabunche International Airport in Brazil.

Early last year, NAL informed Bolche Inc. that due to worsening financial situation and reduction in business it no longer wished to take delivery of the airplanes. However, it would wish to acquire only two much smaller aircrafts. Bolche Inc. di not reply to the communication from NAL.

Last week, NAL received a notice from Bolche Inc. advising the former to take delivery of two of the dreamliners ordered at the agreed place of delivery, namely Rabunche International Airport. They have advised, indeed warned, that continued and extended storage/parking of the two aeroplanes will attract charges.

Address the legal issues arising and the relevant remedies to each party, if any. (20 Marks)
